

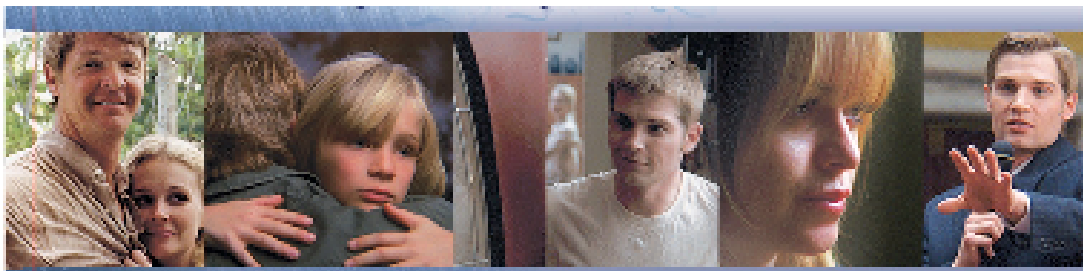
HEAVEN'S RAIN

HOSTING A SCREENING

Thank you for your interest in hosting a *Heaven's Rain* screening. This movie has proven to be a powerful tool for spurring meaningful conversations about family, faith, forgiveness, and policy reform. We appreciate you joining us in this journey to bring healing and forgiveness to the forefront.

To host a screening with your organization, you will need to:

- ❑ Own or rent quality audio-video DVD equipment and one large viewing screen.
- ❑ Purchase a Heaven's Rain Licensing Kit for any showing to 25 or more people. This kit comes with a copy of the movie, a Heaven's Rain Event Guide, and access to publicity material. The licensing kit is \$299 per showing. See www.heavensrainmovie.com/screenings to purchase the agreement online or complete the agreement included in this packet.
- ❑ Sign the Heaven's Rain Public License Agreement (attached).
- ❑ Decide on a ticket price. It can be free or you can choose to make the event a fundraiser for your organization or another worthwhile non-profit in the community. We recommend a ticket price of \$5-\$15 per person.
- ❑ Consider inviting local community leaders (e.g. pastors, politicians, law enforcement), local press (TV, media, newsprint) and victim's right or counseling group leaders to the Heaven's Rain showing.
- ❑ Spread the word. To help you get the word out, we've created a password protected site with all of our publicity materials, including movie trailers, graphics, logos, and clips. Please email britt@heavensrainmovie.com for a password to access these materials. You can use Heaven's Rain graphics and logos to create unique event invitations, save-the-date emails/cards, posters and e-mail blasts.
- ❑ Use the Heaven's Rain Event Guide. This guide comes with a checklist of pre- and post-event suggestions, a sample introduction and background information, and thought-provoking discussion questions for a group discussion after the movie.
